## UPDATE ON REORGANISATION PROCESS – TOWN HALL MEETINGS ON 19 JULY 2018 AND 20 JULY 2018

---

The Board of Directors of Hyflux Ltd. (the “**Company**”) refers to its announcements made on 22 May 2018, 25 May 2018, 28 May 2018, 4 June 2018 and 11 June 2018, 19 June 2018 in relation to the ongoing reorganisation process (each an “**Announcement**”).

As stated in the Announcement on 19 June 2018, and advertised in the Straits Times, the Business Times, and the Lianhe Zaobao on 13 July 2018, the town hall meetings organised by the Securities Investors Association (Singapore) (“**SIAS**”) for the Company and the following stakeholder groups were held on 19 July 2018 and 20 July 2018:

- Holders of S\$100,000,000 4.25% notes due 2018, S\$65,000,000 4.60% notes due 2019, and S\$100,000,000 4.20% notes due 2019 pursuant to the Company’s S\$1,500,000,000 Multicurrency Debt Issuance Programme (19 July 2018 at 12 noon)
- Holders of Hyflux Ltd.’s S\$500 million 6.00% Perpetual Capital Securities (SGX:BTWZ) (19 July 2018 at 7 p.m.)

(collectively, the “**Securities**”)

- Holders of Hyflux Ltd.’s 6% Cumulative Non-Convertible Non-Voting Perpetual Class A Preference Shares (the “**Preference Shares**”) (19 July 2018 at 7 p.m.)
- Ordinary shareholders of the Company (20 July 2018 at 7 p.m.)
